1. General terms and conditions

In this section is to be filled the needed details from the latest membership register of the association. In the section 'Number of persons participated actively in the activities' is to be filled the number of such persons in respect of the membership who actively and regularly participate in various activities organised by the association.

2. Regular group activities

Refer to regularly implemented activities of the association. These kinds of activities can consist, for example, of diverse clubs or themed events organised weekly.
