



Transport benefit application for students in special subject emphasis classes and the Oulu International School for the 2025–2026 semester - Instructions and application form

The transport costs of students in special subject emphasis classes and the Oulu International School are the responsibility of the guardians, even if the distance to school exceeds 5 km and regardless of the distance to the student's local school.

Students of basic education's special subject emphasis classes and the Oulu International School may be granted a transport benefit based on an annual income limit. The transport benefit is only granted as Waltti bus cards delivered to the student. The Waltti card enables the student to utilize Oulu's public transportation for school travel. The transport benefit is applied for with the form on the next page.

According to the Education Committee's decision, students of special subject emphasis classes and the Oulu International School may be granted a Waltti card based on income (December 19, 2023 § 153). The Waltti card can be granted annually based on the income of adults living in the same household. The income limit is determined by the active upper limit for low income based on household type ([see the table in the section Applying for a discretionary school transport benefit on the page Way to School and School Transportation on the city of Oulu website](#)). Income will be determined according to taxation data from the past year. If income has changed substantially in comparison to the taxation data, an exemption will be granted based on presented proof based on previously mentioned income limits.

Proof of income and taxation must be delivered with the application. Significant changes to income during the semester will be considered (reduction). If income changes, the guardian may file the transport benefit application at any time. Then, the transport benefit can be granted for a part of the semester. Transport benefits are applied for one semester at a time.

If the guardian wishes to apply for transport benefits, **the application form on the next page** must be delivered **by August 31, 2025**, to the address: Oulun kaupunki, sivistys- ja kulttuuripalvelut / Kuljetusetuushakemus, PL 17, 90015 OULUN KAUPUNKI. Late applications will not be processed for the 2025–2026 semester. Until the Waltti card is granted, the guardian is responsible for transport costs.
